

Amendments made to Tariff of Corporate Banking Services

CNY Remittance Services-Overseas Cross-Bank CNY Remittances:

- 1. Remittance Commission Fee: 0.1%, minimum CNY100/ per transaction, maximum CNY500/ per transaction. Additional charges will be charged in case of oversea agency fee;
- 2. Overseas Agency Fee: CNY120
- * If the above charge is insufficient to pay the agency fee, the insufficient part will be collected upon the notice of agency bank 3. TT Amendment/Enquiry/Cancellation: CNY200

- Add inward return payment commission fee
- Add overseas agency fee

- 1. Inward Return Payment Commission: CNY150/equivalent
- 2. Overseas Agency Fee: USD Remittance: USD26/equivalent

- 3. Standing Instruction: CNY200/equivalent per transaction
- SWIFT MT940/MT950: CNY800/equivalent per account per month
- SWIFT MT942: CNY1,500/equivalent per account per month
