本人理解和同意: I understand and agree that:

- 本授权书为一次性授权书,仅用于上述明确授权办理的事务,代理人基于本授权书行事时受限于并应遵守相关的法律法规以及贵行的内部操作规程。
This power of attorney is a one-off authorization in nature and applies only to the matter specifically authorized as above. All operations conducted by the agent pursuant to this power of attorney shall be subject to and comply with all relevant laws and regulations as well as internal operational requirements.
- 贵行有权全权决定拒绝接受代理人根据本授权书代办业务,且贵行无需对因此造成的任何损失(如有)向本人或任何其他人士承担任何责任。
The Bank reserves the right, in its sole discretion, to refuse to accept this power of attorney and the Bank shall not be held liable to me or any other person(s) for any loss (if any) so caused.
- 代理人必须携带和出示本授权书原件及其身份证明文件原件。
The agent should present the original copy of this power of attorney and ID document (original) of the

agent when acting in accordance with this power of attorney.

- 对于现钞存入业务,若存款金额为人民币 5 万 (含) 以上或任意金额的外币现钞, 还需携带账户持有人本人的身份证明文件原件。外币现钞存入额度为个人当日累计等值 1 万美元 (含), 每月可办理最多 2 次累计金额不得超过等值 1 万美元 (含) 的外币现钞存入, 每年累计金额不超过等值 5 万美元 (含); 若超过每日额度、每月次数或年度累计金额, 须提供相关证明材料 (如: 经海关签章的《海关申报单》或账户持有人原存款银行外币现钞提取单据)。

For Renminbi cash deposit of amount exceeding RMB50, 000, or foreign currency cash deposit, the agent shall present the ID document (original) of the account holder. The daily personal quota of foreign currency cash deposit is USD10, 000 or equivalent, and that each customer can make the deposit at most twice per month, and total amount not exceeding USD 10,000 or equivalent per month and USD50, 000 or equivalent per year. For the deposit beyond the daily quota, the above mentioned monthly frequency or yearly limit, the agent shall provide the supporting documents (e.g.: Customs declaration forms or bank receipt for the withdrawal of foreign currency banknotes).

- 对于结汇 / 购汇交易, 代理人必须携带和出示账户持有人本人的身份证明文件原件; 对于年度限额内的结汇 / 购汇, 代理人还需携带和出示账户持有人与代理人之间的近亲属关系证明原件; 对于年度限额外的结汇 / 购汇, 代理人还需携带和出示符合相关外汇管理规定的证明文件原件; 贵行对由于文件不齐全和 / 或有缺陷而造成的处理失败或迟延不承担任何责任; 贵行并保留权利不予处理违反相关外汇管制规定的任何交易; 结汇 / 购汇适用的汇率为贵行处理交易时的贵行外汇牌价。

For conversion between Renminbi and foreign currency, the agent must present the ID document (original) of the account holder. For conversion between Renminbi and foreign currency within the applicable annual quota, the agent must also present original supporting document(s) evidencing the immediate family member relationship between the account holder and the agent; while for conversion between Renminbi and foreign currency beyond the applicable annual quota, the agent shall also present original copy of supporting document(s) as required for compliance with relevant foreign exchange control regulations. The Bank shall undertake no liabilities for failure or delay in executing the relevant transaction caused by incomplete and/or defective supporting documents. The Bank reserves the right to refuse to execute any transaction which does not comply with relevant foreign exchange control regulations; and that the foreign exchange rate applicable to the conversion between Renminbi and foreign currency shall be the Bank's board rate applicable at the time of the Bank's execution of the transaction;
