

**Why are we asking you to complete this form?****我们为何需要您完成这份表格？**

To help protect the integrity of tax systems, governments around the world are introducing a new information gathering and reporting requirement for financial institutions. This is known as the Common Reporting Standard (the CRS).

为协助打击逃税，维护税制完整，全球各地政府现正推出适用于金融机构的资料收集及汇报新规的要求，名为共同汇报标准（简称“CRS”）。

Under the CRS, we are required to determine where you are “tax resident” (this will usually be where you are liable to pay corporate income taxes). If you are tax resident outside the country/jurisdiction where your account is held we may need to give the national tax authority this information, along with information relating to your accounts. That may then be shared between different countries’/jurisdictions’ tax authorities.
