根据监管关于重大事项报告的要求，现将产品重大事项调整报告如下：

因圣诞节假期原因，德国法兰克福证券交易所于2020年12月24日至2020年12月25日休市，伦敦证券交易所于2020年12月24日至2020年12月28日休市，根据产品销售文件中关于“非预定交易日的调整”的约定，本产品的“最后一个观察期的提前到期观察日”由条件清单中约定的原定日期2020年12月24日顺延至下一个两地交易所交易日2020年12月29日，本次调整不涉及其余产品相关参数。

In Accordance to regulatory requirement on Significant Event Reports, the related adjustments are now announced as follows:

Due to Christmas Holiday, the Frankfurt Stock Exchange closed from December 24 2020 to December 25, 2020 and London Stock Exchange closed from December 24 2020 to December 28 2020. According to the definition of “Adjustment due to Non-Scheduled Trading Day” in Sales Documents and, the “Early Maturity Observation Dates of the final Observation Period” has been adjusted from December 24, 2020, originally recorded in term sheet, to the next trading day of the two exchanges as December 29, 2020. This adjustment shall not impact other product related parameters.
